

# Important Update – PLEASE READ

## Revised P&G Pet Care Recall Procedures

Updated August 3, 2010

- P&G, in conjunction with the approval of the FDA, has revised the recall plan and you are now authorized to immediately destroy and dispose of the product.
- A form certifying you have removed product from the shelf and physically destroyed the bags (tear, cut and empty into trash) will need to be filled out completely, be signed by a Manager or Owner and faxed back to Summit Pet no later than Friday August 13<sup>th</sup>, 2010.
- Remember to wash your hands after contact.
- Attached you will find the revised form to certify destruction and disposal.
- Please keep a copy for your records as the FDA will be doing spot audits to assure all product is destroyed.
- Once we have the form – Summit will issue a credit for the product + a .50 cents handling fee per bag.
- If a Customer has no product – the form will need to indicate Zero Product and be signed and faxed back to Summit Pet.
